ASKS

to be entitled to use (at his own risk) with/without exclusivity on **August 7th, 8th and 9th, 2010** the track of the Autodromo Internazionale del Mugello, understood and agreed that MUGELLO CIRCUIT S.p.A. reserves the right to modify the track utilisation, both if exclusive or not, even during the trial, and also the right to eliminate or interrupt such utilisation.

Relating to the above mentioned requests, the undersigned declares:

- 1) to use the track under the conditions of the regulations, already duly accepted;
- 2) to stand surety in the widest way the MUGELLO CIRCUIT S.p.A. for himself, his successors and the assigns from each and every obligation to pay compensations of any kind or title for damages, indemnities, refunds, etc., in case of any accident, of whatsoever duration, result and relevant consequences that can happen to the undersigned during the trial, and whichever the cause of the accident due to anyone, comprising the above mentioned society, its organisation, responsible and all employees, and in general any other person interested to some extent.

The undersigned also declares to stand surety in the widest way the MUGELLO CIRCUIT S.p.A. for himself, his successors and any assigns from the demands that can be made at any title by third parts as a consequence of the utilisation of the undersigned of the Mugello track. As third parts also the drivers of other vehicles and the persons possibly carried are to be meant, as well as his escorts here below listed:

The undersigned releases the MUGELLO CIRCUIT S.p.A., its staff and in any case the persons assigned to the motor-racing track from each and every liability that should arise as a consequence of the trial that the undersigned intends to perform;

The undersigned also specifies to have a suitable personal insurance covering for every accident.

That being stated, the undersigned also declares:

- 1) to have specially taken note of the norms and cautions to be observed from those using the track, and to accept without reserve such norms and cautions;
- 2) to have taken note of the tariffs and of the other conditions in force for the track use, and to accept them;
- 3) that related to the before stated, the above mentioned vehicle is perfectly fit for the trial the undersigned intends to perform;
- 4) to engage, undertaking in this respect each and every civil and penal liability towards third parts or assigns, not to grant to any other persons the authorisation to drive with that a.m. vehicle.

The undersigned expressly confirms all the above at each and every effect of law.
